# **Annual Report 2006**



#### Short history:

Very late delivery of scientific and financial information

■ February 15: submission (w/o CNRS) on deadline

early March: CNRS numbers & documents delivered

• mid March: submission of corrected report

(after discussion of some specific questions with Brussels)

■ April 26: comments on scientific part received (mostly minor), answered quickly

■ July 6: comments on financial tables received (benign), answered quickly

■ July 13: more severe comments received on financial part

• August 9: all comments answered (thanks to Aurore & Cedric!)

■ September 12: approval of Annual Report

■ September 19: reception of 2nd instalment

September 25: transfer of 2nd instalment to partners

## Conclusions for coming reports:

- we were about 1 month late with the complete report
  - ... and ended up at the bottom of the pile check of financial part started only in July
- we overlooked some important mistakes in the rush (mea culpa)
- We must avoid this in future and undertale ALL efforts to submit in time!
- Next Annual Report has to include audit certificates (for all partners)
