4. Results

- It was a memorable visit where discussions on the ILC were held with influential parliamentary members and upper levels of the governments in France and Germany (to be expanded to more countries).
- The importance of S&T cooperation between France-Japan, Germany-Japan, and Europe-Japan was recognized. In particular, a common understanding was reached among the participants the necessity of international sharing to realize the ILC.
- The importance of incorporating the ILC project into the European strategy for Particle Physics was recognized and shared among the participants.
- Objectives of research at the ILC, consistency with the LHC, features of round and linear accelerator, and the role of researchers were recognized.
- A common understanding was reached for the basic framework of the ILC project (timing, cost, international collaboration, role of host country, in-kind contribution, etc).
- Counterparts of French-Japan and Germany-Japan are established at four levels. We can start discussions among the countries to realize the ILC.
- Possibility of France-Japan and Germany-Japan cooperation for the ILC in industry/economy world, and cooperation between AAA and French/Germany industries were discussed.
- There were discussions on the relation of European strategy for Particle Physics and Horison 2020, GSO (Group of Senior Officials on Global Research Infrastructures), ESFRI (European Strategy Forum on Research Infrastructure) and so on.
