Shoji (Asai: ATLAS Japan Spokes Person) made his excellent report of the ILC250 Science in contrast with the HL-LHC with emphasizing the critical importance of the ILC running together with the HL-LHC, Masa (Yamauchi: KEK-DG) sharply pointed out the importance of the SCJ recommendation focusing on the judgement on the "green-light" for staring the formal negotiation with other countries by the Japanese Government. He also reported the European collaboration (ILC preparation plan), US collaboration (cost reduction R&D and recent HEP budget increase in USA), IHEP (China), India collaborations.

They were very good presentations. The physical significance of ILC, the role of KEK and international cooperation were well understood, I thnk.
