

HRs in the ILC Pre-lab period

At the 15th IDT-WG2 meeting, a table of human resources in the ILC pre-lab period was presented. The DR/RTML/BDS part of this table was tentatively prepared by me.

Since this was prepared in response to a hurried request to submit to MEXT, the numbers became open without any explanation in the previous group meetings, so I will explain how they were calculated.

<< Prerequisites >>

- This is a hastily prepared document to be submitted to MEXT.
- It was necessary to prepare the global and Japanese domestic human resources in the submitted materials.
- The number of human resources needed to be consistent with previously published materials.
 - > TDR evaluation
 - KEK action plan etc.
- Regarding human resources in the pre-lab period, two documents (TPD and ED&D) have been or will be submitted by IDT, and the contents need to be consistent with these documents.

Summary table of FTEy

- Since HR estimation was asked me before we discussed what we would do in the Pre-lab period as WBS, the FTEs were estimated in such a way that they fit with the KEK action plan and the total TDR.
- At the present stage, it is an estimate that does not go beyond the range of "number plays", so it will be necessary to re-estimate it in more detail in the future budget application stage.
