

New ILC Promotion Scheme in Japan 2







Plan in the next few years

- Create a new international collaborative framework to implement the most urgent work packages in advance.
 - We believe that it is highly likely that the budget for this will be approved in Japan in JFY2023.
 - Detailed R&D plan is being elaborated in the IDT-WG2.
 - We are about to start discussions with related laboratories to exchange MOU's between the laboratories.
- An international working group will be set up to deepen discussions in two or three stages, and then, hold meetings to explain the progress to the representatives of the relevant governments. With this as a starting point, we will encourage intergovernmental discussions on the ILC.
 - Membership will be discussed with IDT, and proposed to ICFA.
 - At least one meeting attended by the government representatives will be held in one year.

Plan of action (1)

We plan to take to two immediate actions, which is in line with the recommendations in the ILC Advisory Panel report, and were proposed to ICFA by IDT.

- 1. Action for preparation of an international collaboration of accelerator R&Ds
- 2. Action toward international discussions between MEXT and potential foreign governments
- 1. A new international framework of the accelerator R&D
- KEK has been taking to MEXT on the budget request for JFY 2023.
- The MEXT officer said in the Five-party meeting that MEXT will consider R&D through international collaboration and cooperation as recommended by the ILC Advisory Panel.
- The budget plan is now formulated by IDT-WG2. KEK with help of IDT would like to talk to potential participating laboratories concerning the international collaboration soon.
- For the JFY2023 budget request, KEK will submit the budget plan in June and the MEXT will decide whether they request the budget or not in the end of August. If successful, the budget will be included in the governmental budget plan in December 2022.
- KEK will make efforts to secure a significant increase of relevant accelerator R&D budget.

Plan of action (2)

2. Toward international discussions

- KEK, ILC-Japan and IDT are discussing how to facilitate discussions among MEXT and potential foreign governments.
- MEXT said that they are prepared to join meetings with the other governments to discuss how the counties concerned can cooperate to support large research facilities such as Higgs factories in the future.
- KEK, ILC-Japan and IDT are considering a step-by-step approach. As the first step, we will
 organize an international working group to prepare a discussion document on lifecycle of the
 project. This will serve an input for the following discussion with involvements of
 governmental levels.
- KEK and ILC-Japan communicate with MEXT closely in starting and proceeding of the working group.
- MEXT also said that they would like to continue exchanging opinions with the other governments by, for examples, utilizing existing frameworks. We like to support such efforts as well.
